Many volunteers have qualifications and have either timed out or only want to do basic tasks as volunteers rather than work as an OC member in the future. Focus has been on recruitment of individuals who are interested. We have good progress in having 2 potential Competition Secretaries, 1 Chief of Timing and potentially an entirely new Organizing Committee (OC) for an OK Cup. A meeting has been scheduled in April to discuss requirements and willingness with this group.	In progress (will be ongoing forever!)
